The request must be submitted to PHA 90-120 days prior to the effective date of the tenant's regular recertification. **In order to be approved, this form must be completed in its entirety. The owner must be in compliance with all PHA certification requirements.**

Upon receipt of your completed request form PHA will process your request to determine if the requested rent is reasonable in comparison with comparable units in the private market. If your request is approved the rent increase will be effective in on the tenant's regular recertification date. **If your rent is not reasonable in comparison with comparable units in the private market PHA will decrease your rent.**
